“Always be thankful, and thank others for everything they do for you,” a motto Sea Cliff’s Breen family lives by and put into action last week. Molly and John Breen, and their daughter Frances look at the glass half full and not empty. They are grateful to the doctors at Nassau University Medical Center who saved Molly’s life and in a press conference and return visit last week she thanked them all with a warm smile and hugs.

Seven-year-old Molly received fourth degree burns on Easter Sunday when her dress caught fire while she stood next to an open fire pit. She then ran into the house where her aunt, Mary Haff, who is an emergency room doctor, wrapped her in a blanket to extinguished the flames.

Sea Cliff Fire Department Volunteers under the direction of Chief Mark Vitale quickly arrived and, with the aid of a Nassau County Police helicopter, Francis was quickly transported to NUMC burn-treatment unit.

Looking at the bright side and being grateful, Molly’s father John said, “Everything happened in our favor that day. Everyone was in place and everyone knew what to do.”

Molly would spend a total of 59 days at NUMC. Her family reported that they were grateful everyday for the love and support the staff provided. Molly said her daughter's, "Miraculous recovery from the life-threatening burns is a direct result of the talented and passionately dedicated doctors and nurses of Nassau University Medical Center."

"When Frances had her accident, this hospital really became our home and the staff became our family in more ways than we can count. They gave us the kind of day-to-day hope and support that we needed, we so desperately needed." Doctors expressed gratitude to the Breen family and to Molly as well, saying her upbeat attitude and smile made it possible. Dr. Louis H. Riina said, "she was able to work through the pain of such severe burns thanks to her willingness to see the positive."

The family presented the Hospital staff with two bronze plaques thanking them for the incredible work they did in saving Molly's life.

On the day of the event, Molly danced around the camera's and reporters, singing and showing her gratitude in a way a seven-year-old does... but most

importantly she said to each of the staff members and doctors, "Thank you for saving me."

North Shore Historical Museum Host Mock Trial

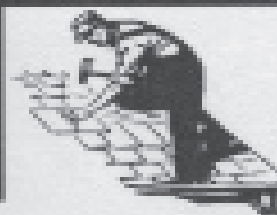
On Election Day, November 8, the Glen Cove Boys and Girls Club came to the North Shore Historical Museum for a mock trial. They were assisted by Nassau County District Court Judge Paul Meli. The kids assumed the roles of attorneys and witnesses in the trial of Goldilocks. Goldilocks was found guilty of bad manners but thanks to Judge Meli's counsel, she avoided jail time in courthouse jail and instead was given community service.

The NSHM Mock Trial Program in Glen Cove is an exciting and cooperative way for young people to not only learn about the law and legal system but to do so in a historic, local setting. The 1 ½ hour program includes a tour of the building, including jail cell, and 1-2 scripted mock trials. Trial scripts range from fairy tale fiction to historic events and be prearranged to suit age group and reading level. Trial scripts can also be customized to match students' school, names, teachers, etc. Participants experience first hand the difficulties that judges, lawyers and juries face in determining which facts are relevant and what legal arguments are effective.

Glenwood Landing Fourth Graders Participate in Native American Culmination Day

After months of intensive study on the Native American unit including a hands-on visit by Tipi Ted and the Traveling Wilderness Museum as part of the social studies curriculum, fourth graders at Glenwood Landing School participated in a Native American Culmination day.
