The Scrooge Stroll Returns To Sea Cliff!

On Sunday, December 4th, Ebenezer Scrooge will get another chance at redemption, as he wanders the streets of London (or, in this case, Sea Cliff), and learns the true meaning of Christmas. It's the second annual Scrooge Stroll, a "moving" re-enactment of Charles Dickens' classic novel "A Christmas Carol", presented by the Sea Cliff Civic Association.

The Scrooge Stroll, the brainchild of local theater-buffs Dan and Ann DiPietro, is a unique version of the famous tale about the miser who is visited on Christmas Eve by a number of spirits, and shown the error of his ways. Adopting a "site-specific" strategy, the Stroll makes the village of Sea Cliff its stage, with the audience following the actors as they move from place to place to tell their story.

Kicking off at the Centennial Garden on Sea Cliff Avenue, the Stroll will meander down the main and side streets

Glen Cove Toys For Tots Event to Support VetDogs



On Sunday, December 4 from 8:30 – 10:00 a.m., Glen Cove's Downtown will be a holiday wonderland. Santa will take time from his very busy schedule to thank everyone who donates unwrapped toys and the volunteers who will be filling trucks with countless donated toys.

Every year, the U.S. Marine Corp Reserves Toys For Toys program organizes this and other community toy collections across Long Island. But, there are two additional features that make Glen Cove's event extra special. One is that there will be dozens of high performance cars on hand for attendees to preview before adding one to their holiday wish lists.

Another is that, for the first time, this year's event is also supporting America's VetDogs. This important organization specially trains assistance dogs and places them with veterans, active-duty service members and first responders with disabilities. These dogs help these American heroes to become more mobile and self-reliant. It costs over \$50,000 to breed, raise, train and place one assistance dog. America's VetDogs, a 501(c)(3) not-for-profit, provides its services completely free of charge.

"The U.S. Marines Toys For Tots program is such a great event that embodies everything the holiday season is all about," Nassau County Legislator Delia DeRiggi-Whitton said. "Including education about and donations to America's VetDogs makes the event so heartwarming in that it supports children and veterans, two causes that are very near and dear to me."

"The Toys For Tots toy drive keeps getting bigger and better each year," Event committee member Joe LaPadula added. "With the addition of the VetDogs fundraiser this year, the event is exactly what holiday spirit is all about."



Bruce Kennedy Appointed Village Administrator Edward Lieberman Appointed Mayor

At a meeting held on November 28th Bruce Kennedy tendered his resignation as Mayor of the Village of Sea Cliff and was then appointed as the Village Administrator. The Board of Trustees appointed Trustee Edward Lieberman to complete the term of Mayor ending in April.

John Mirando resigned from his position as Village Administrator on November 7th to accept a position in the City of Long Beach. Monday's meeting was convened to review applications and resumes that had been submitted to the Village for the Administrators position. Trustee Robin Maynard stated "Mayor Kennedy had voluntarily and without compensation stepped up to fulfill the responsibilities of the Administrator's role until a replacement had been found. This is one of the leadership qualities that Bruce always exhibits; he just steps up and gets things done."

Trustee Kevin McGilloway stated, "The Board of Trustees is deeply appreciative

Trustee Kevin McGilloway stated, "The Board of Trustees is deeply appreciative of Mayor Kennedy's hard work and commitment to the Village. For the past 8 years the Village has been blessed with a hands on Mayor that gets things done. Being that the Mayor was wavering on whether he would seek re-election in March, the Board and I thought that this was an incredible opportunity to get Bruce on the staff. Ed is the senior Trustee and the obvious choice for our next Mayor."

Trustee Dina Epstein expressed her gratitude and admiration for Mayor Kennedy's results driven mind set. "Bruce is the person that you call when things need to get done. He is never focused on the problems, only the solutions. He was the obvious choice to fill the role of Village Administrator. Newly appointed Mayor Edward Lieberman was in complete agreement and added "I am honored to succeed Mayor Bruce Kennedy as the Mayor of the Village of Sea Cliff, Bruce has been a mentor to me, always providing vision, support and guidance. He has left a huge set of shoes to fill and I am appreciative of the Board's vote of confidence in me. The Village of Sea Cliff has become a jewel of the Gold Coast under his esteemed leadership and achievement. I look forward to serving the residents of Sea Cliff in my new capacity."

Kennedy owns two businesses that he will be divesting himself from after 30 years but sees this as a new challenge and opportunity. "When the offer of the position was raised, I was torn. This is an incredible opportunity for me to continue the work of public service to my community in a new role. While I would have rather completed the last few months of my term, the two positions are incompatible and should not be fulfilled by a single person." Kennedy concluded, "I am so incredibly grateful to the residents of Sea Cliff that elected and trusted me for my 4 terms as Mayor. I am looking forward to this new chapter and position. Edward Lieberman is a good man and I am fully confidant in his ability to lead our Village as Mayor."

Glen Cove HS Youth Step Up and Call for a Reduction of Tobacco Marketing on GASO 2016

Glen Cove High School students took a stand for the "Great American Smoke Out 2016" (GASO) to call attention to the need to reduce their exposure to tobacco marketing through awareness activities organized by the SAFE Glen Cove Coalition School Committee Chaired by Denise Kiernan, Director of Athletics for Glen Cove School District. The Teens actively challenged smokers to a smoke free day, and hopefully a fresh start of kicking the habit.

GASO is a day of national activism sponsored by the American Cancer Society. Each year, the Great American Smoke Out draws attention to preventing the deaths and chronic diseases caused by smoking. Throughout the late 1980s and 1990s, many state and local governments responded by banning smoking in workplaces and restaurants, raising taxes on cigarettes, limiting cigarette promotions, discouraging teen

cigarette use, and taking further action to counter smoking.

The School Committee is pleased to once again be partnering with the Tobacco Action Coalition of LI, and their "Seen Enough Tobacco" campaign to reduce our youth's exposure to tobacco marketing. 'Our local youth have stressed that they feel CVS's decision to ban the sale of tobacco demonstrates the importance of this campaign in bringing awareness to the public and our elected officials of the need to reduce their exposure to tobacco marketing", per Ashley Ferrufino-SAFE Coalition Liaison. "Further tobacco marketing has been declared a youth epidemic by former Surgeon General Benjamin, so today we are encouraged to see our next generation step up and call for a reduction in youth's exposure to tobacco marketing".

and the techniques used by the tobacco industry to advertise their products manned a table with materials supplied to SAFE and TAC to educate their fellow classmates, and Health Teacher-Anthony Gallo besides his daily in class education played PSA's provided by TAC to garner the attention of the faculty and student body. The teens were encouraged to raise awareness with their peers and adult leaders of the problems of tobacco use in their community, and the misleading message associated with tobacco sales in local pharmacies. This day of national recognition empowers youth to stand out, speak up and seize control against "Big Tobacco".

About 40 million Americans still smoke cigarettes, and tobacco use remains the single largest preventable cause of disease and premature death in the world. In New York, \$235 million a year, or nearly \$650,000 a day, is spent on marketing tobacco products and 280,000 kids under 18 today in NYS will ultimately die prematurely due to smoking. In fact, if the current smoking rates continue 5.6 million Americans younger than 18 who are alive are projected to die prematurely from smoking related diseases.

"Tobacco sales in pharmacies begs the question, as tobacco is the only consumer product that when used as intended, will kill at least one half of its long term users; why is it still being sold in pharmacies? Its displays in stores and local pharmacies give youth the impression that tobacco products are easily accessible and tobacco use is an acceptable behavior. We are so proud of the activism of the teens at Glen Cove High School; and are grateful for our continued partnership with SAFE as we have seen many teen leaders emerge over the years," said Carol Meschkow-Nassau Coordinator for the Tobacco Action Coalition of LI.

"Smoking is deadly, and we need

to work together to protect our impressionable teens from the lure of this dangerous product; and that's why the Physical Education and Athletic Department for the Glen Cove School District is particularly concerned. We strive to motivate, and stress the importance to our teens of taking a stand and speaking out for themselves. It is satisfying to see our students advocate for causes that they believe in, such as challenging local pharmacies to reconsider the display of deceptive tobacco marketing promotions", said Anthony Gallo- GCHS Health Teacher.

According to Dr. Sharon Harris-Executive Director of Glen Cove SAFE, "A study recently released by the American Cancer Society found that smokers toll on health is worse than previously thought. The study found five additional diseases attributable to smoking and estimated that an additional 60,000 deaths each year in the US are due to tobacco use. This alarming statistic brings the total annual death toll to 540,000 people dying every year due to smoking related diseases. In NYS 108,500 High School students smoke cigarettes and each year 135,000 kids initiate their addiction as daily smokers".

In New York State, 82 percent of retailers including pharmacies, convenience stores and gas stations occupy at least half of the space behind counters to openly display tobacco products for all to purview. The Glen Cove High School student leaders have seen enough tobacco marketing and are banding together with the same message, "we want to be the first generation to be tobacco free!"

Glen Cove Youth Bureau Adopts Smoke-Free Entryway Policy

In keeping with their philosophy and efforts to promote health and wellness, the Glen Cove Youth Bureau has along with the Tobacco Action Coalition of LI (TAC) implemented a Tobacco Free 15-foot entryway ban at their facility in Glen Cove. The entryway is now a smoke free zone with smoking and use of any electronic or vaping devices strictly prohibited.

"The Glen Cove Youth Bureau shares many of the TAC's concerns, most notably keeping our youth from becoming the next generation of smokers. We make every concerted effort to create a culture of wellbeing by offering programs teaching and encouraging our kids to adopt healthy habits and make smart decisions. By prohibiting smoking, we are taking yet another positive step to ensure that we promote an environment of wellness for our youth and our community. We hope our decision to implement a smokefree entryway will inspire smokers to make quitting a priority, and protect our impressionable youth from ever starting this dangerous addiction," said Glen Cove Youth Bureau Executive Director Spiro Tsirkas.

The Tobacco Action Coalition, funded by grants from the NYS Department of Health Tobacco Control Program, is one of 25 Community Partnerships working toward advancing tobacco free communities. Under this initiative, TAC is working with businesses and community organizations to implement voluntary entryway bans and tobacco free grounds as well as educating local municipalities about the benefits of adopting tobacco use restrictions for playgrounds, parks, beaches and other outdoor recreational areas. Through this proactive partnership

with TAC, the Youth Bureau has joined the ranks of nearly 500 municipalities statewide and several hundred businesses, health care facilities, libraries and community agencies in creating policies to protect the public from the dangers of second-hand smoke, cigarette litter, and addressing the need to change the social

norms associated with the acceptability of tobacco usage, especially among our impressionable youth.

North Shore Middle School Participates in "E3" Day 2016

"Everyone Matters, Everyone Cares, Everyone Learns"

North Shore Schools, Glen Head, NY -North Shore Middle School Principal Dr. Marc Ferris stated, "On November 22nd, our students experienced something quite different. On the day before Thanksgiving break, we did something wonderful and inspiring. Over 650 of our students celebrated E3 Day together making a difference in the lives of others. Everyone Matters, Everyone Cares, Everyone Learns (E3) is our middle school ethos, our vision for who we wish to be and what we hope for our students. E3 Day encourages our students to learn about themselves and others; thinking about ways they can make a positive difference in their school, and the world around them."

E3 Day 2016 began with the Annual Thanksgiving breakfast, cooked by the middle school teachers. An assembly was held in the gym with guest speaker, Hudson Taylor, a three-time NCAA Division I All-American wrestler and former wrestling coach at Columbia University, who now is a prominent straight ally and civil rights activist of LGBT rights. Mr. Taylor said, "For me and my generation, LGBT rights are a pressing issue. I believe that whatever history I'm a part of, I'm responsible for. If I feel something is unjust or unequal, I feel a responsibility to do something about it." His mission is to spread a message of equality and inclusion as the founder and executive director of Athlete Ally, a non-profit organization dedicated to educating and activating athletic communities to eliminate homophobia and transphobia in sports and to exercise their leadership to champion LGBT equality.

During the course of the day, students, faculty and staff engaged in numerous activities and fundraising events. Dr. Ferris said, "What a day! We are all so proud of our children. Here is just a small sample of the great work accomplished on this one single school day:"

- 4574 Cans or boxes of food were delivered to a local food pantry as a result of our breakfast exchange
- 7 boxes of toiletries and shampoo were delivered to a homeless shelter \$5,000 and counting was raised for our Relay for Life Team Live Strong from bottle flipping
- \$2,908 was raised for the Nicholas Pedone Foundation from our Basketball Challenge and Turkey Bowl
- \$1,280 was raised from our dance-athon and pond-a-thon activities Many birds were created for our windows to help save our feathered friends
- A Peace garden and organic garden boxes were built and installed on our school grounds
- A beautiful new mural was painted that will be installed in our library. \$1,091 was raised during our bake sale for the Crohn's and Colitis Foundation

- 1,000 cookies were baked and packaged for families at the Glen Cove Senior Center
- 18 birthday boxes were made for the Make-a-Wish Foundation
- 15 students went to the Trinity Church in Roslyn and helped to clean the grounds
- 42 students raked yards for seniors throughout the North Shore Community
 22 students went to the Glen Cove
- 22 students went to the Glen Cove Senior Center to bring smiles to our seniors
- 42 students helped to raise \$147 and counting by making Crayons for Cancer!
- Over \$5,000 was raised for the Andrew Fierstein Live Strong Relay for Life Team

Dr. Ferris concluded by saying, "I am so proud of our students who continue to prove time and time again that when you set your mind to something, hundreds of adolescents can and will rise to a challenge and make a difference in our world."

Overdose Reversal Training Draws Large Crowd

Over 100 people packed the Glen Cove Fire Department meeting room recently for a Narcan training and education session that was co-sponsored by the Glen Cove EMS and Nassau County Legislator Delia DeRiggi-Whitton. Presenters shared personal family stories of loss and addiction, discussed the warning signs of opiate use, explained the triggers to how abuse escalates from pills to heroin and reviewed other important information before conducting the Narcan training.

Users who become addicted to heroin often start with opiates in pill form. These highly addictive drugs are very hard to kick, even long term. Once the brain receptors open to these drugs, they never close. So, it becomes a long term, even lifelong battle to resist going back to them, whether an oxycodone pill or heroin.

It doesn't take long before the pills aren't strong enough to get the same "high" or they become harder to find. Heroin has become easy to buy and as cheap as \$5 a hit. Because heroin is stronger now than it was when popular in the 1960s and 70s, it can be snorted, even ingested to achieve the same "high" as injections once required.

A particularly compelling speaker

during the event was RoseMarie Sherry, who took Narcan training just in case she could save someone's life someday, having no idea that she would someday need her kit to save the life of her own son. Ms. Sherry's children were good students, boy scouts and were raised in a loving home. So, she is the perfect spokesperson for the, "If it happened in my family, it can happen in anyone's" awareness crusade.

"I know people whose children were saved with Narcan and those who couldn't be saved because they didn't have a Narcan kit," DeRiggi-Whitton said. "As parents and communities, we have to do everything possible to combat this terrible epidemic. Aside from educating our children, an important step in saving lives is for everyone to receive Narcan training and have the kit in hand in case it is ever needed."

Leg. DeRiggi-Whitton wishes to thank all of the attendees and volunteers who helped make the event successful, especially the Glen Cove Fire Department for their generous support overall and allowing the event to take place in their firehouse.





At this time of year, I often find myself returning to MR. IVES' CHRISTMAS by Oscar Hijuelos. When we first meet Mr. Ives, his life appears perfect- abandoned as a young infant, he was adopted into a good home and now in 1954 he is a successful New York businessman with a beautiful, loving wife and two adored

children and buoyed by a deep faith in the goodness of all things. By the second chapter, with the murder of his young son on Christmas Eve, his faith has been destroyed. The rest of the book deals with Ives's struggle to make sense of his loss. While it may seem an odd choice for holiday reading, there is something enormously uplifting about this book as we follow Ives on his journey from a hollow, grieving man to a gloriously forgiving redemptive figure. In many ways it is a contemporary version of Dickens's CHRISTMAS CAROL as we travel back in time to joyful moments and then forward to moments of unspeakable horror and then forward again to Ives's moment of ultimate salvation. 


